**PERSONAL GUARANTY**

Should any payment required by Applicant to Maryland Pump & Tank, Inc. not be made when due, each of the undersigned authorizes any attorney or clerk of any court to appear for him or her in that court (as of any term), at any time there is a violation of any of the terms of credit, and confess judgment against any or all of the undersigned, without giving prior notice to or serving process upon the undersigned, for such amount then owed by the Applicant to Maryland Pump & Tank, Inc., along with costs of suit and attorney's fees of not less than eighteen percent (18%) of the amount then due.
